- Each user iand it's corresponding data is permanently deleted 4-6 months after they their access has been revoked.
- The system logs when a user is logging in to the system. These logs are saved for six months and then automatically deleted. Spendency have no obligation to provide these logs to the Customer and will only do so under when extraordinary circumstances so require.
- Data uploaded into the Service will never be transferred to a third country (a country that is not a member of the EU or EEA and has not received an EC Adequacy Decision),
