

Due Diligence Requirements in the Supply Chain: German Supply Chain Act passed, EU-Directive in planning



German Supply Chain Due Diligence Act (= Lieferkettensorgfaltspflichtengesetz, LkSG)

Objective: Companies should...

- 1. identify human rights and environmental risks in the SC
- 2. address risks
- 3. take preventive and remedial action
- 4. report on them
- 5. establish complaint mechanisms

Implementation deadline:

- Jan. 1, 2023: companies > 3000 employees in Germany
- Jan. 1, 2024: companies > 1000 employees in Germany (SGL)

European Development

EU Commission issued a draft directive on the subject of supply chains (adoption of Directive by 2024):


- 1. human rights violations
- 2. violations of environmental protection regulations
- 3. social rights
- More extensive due diligence obligations (deeper into the supply chain) and claims for damages opened

<u>Supplier Risk Assessment:</u> How we prioritizes our full scale of suppliers with limited resources?






